

Peatland Action Fund and the SRDP - Eligibility Criteria

Peatland Action will **not** fund activities or parties that are eligible for funding under the current SRDP - Agri-Environment Climate Scheme (AECS) (which includes Improving Public Access (IPA)) or Forestry Grant Schemes (FGS). Where it can be demonstrated that there is an overall benefit to the public purse by doing some minor AECS/FGS eligible works, as part of a larger Peatland Action restoration project, we may exceptionally consider support. For example, if without the activities the project will not gain the wider/total site benefits.

Agri-Environment Climate Scheme (AECS) / Woodland Improvement Grant (FGS)

Management options available under AECS/FGS are not necessarily restricted to areas classified as 'rural'. However, there are various options that are only available within certain defined target areas. In AECS, for example, only land within target areas is eligible for the 'Lowland Bog Management' or 'Moorland Management' Options or for rhododendron control. (This [tool](#) shows whether a holding is within these target areas). In practice, virtually all moorland and lowland bog falls within the target areas. For rhododendron control under AECS, if your land is out with the target area, you must obtain an endorsement from SNH and submit this with your application. You can also do so for the Moorland Management option, though that should rarely be necessary.

In FGS, rhododendron control is also [targeted](#) and endorsement is needed from FCS or SNH if you wish to apply out with the target area.

Capital items

The following table lists the capital items available through AECS/FGS that can be relevant to peatland restoration. These items must normally be applied for alongside the relevant AECS/FGS annual recurrent management option:

¹ In order to qualify for a WIG, no more than 20% of the area can be managed as open ground. To this end, peatlands could be managed in clearings, but a management plan to clear-fell trees over more than 20% of the management area would not be eligible.

Otherwise, the item must be applied for alongside the relevant annual recurrent management option.

Peatland Action

There are no geographical restrictions or target areas for Peatland Action funding. Annual management payments will not be funded under the scheme. Peatland Action will consider funding the following work:-

- Bunding
- Combined drain/grip re-profiling and blocking
- Gully re-profiling
- Gully blocking
- Bare peat restoration
- Surface-smoothing and stump inversion
- Hag restoration
- Installation of sediment traps, timber or stone
- Mulching
- Re-use of felled to waste material (e.g. brash, mulch) in restoration
- Capital items for research projects and equipment
- Peat depth surveys*
- Restoration feasibility studies and site condition assessments*
- Collection & collation of baseline data*
- Baseline monitoring following the Peatland Action protocols
- Interpretative materials
- Specialised access
- Community initiatives that include restoration
- Innovative methods and trials as part of a restoration project
